

FINANCIAL AID ELIGIBLE ACADEMIC PROGRAMS / EDUCATIONAL GOALS

Federal regulations require students receiving federal student aid to be enrolled in and make progress toward an **eligible program and educational goal**. If enrolled in a NON-eligible program, as indicated below, students are not eligible for most types of financial aid (grants, loans, work study). However, if otherwise qualified, students may be eligible for the California College Promise Grant.
